The Onshore Safety Analyst Provide integrated HSSE support across the line and ensure that

- Drive and sustain Behavioural Based Safety (e.g. APIPP, etc.) through dedicated safety campaigns, safety notifications and staff information sessions as well as maintaining performance statistics.

- Provide support in the implementation of the Management of Change procedure.
- Support level 2 and 3 audits / site inspections and ensure timely close out of corrective actions.
- Support ISO 14001 certification activities.
- Support Oil Spill Response and ensure the equipment Preventive maintenance program implementation.

- Contribute to the development and implementation of annual HSE plan.
- Support the Lifting and Hoisting activities at the Logistics Base and onshore projects.
- Coordinate onshore PTW systems as Controller including but not limited to, reviewing, approval follow-up, timely monitoring and tracking, auditing and implementation.
- Support onshore HSSE monthly meeting by collecting and compiling the monthly information related to Safe Systems of Work, and supporting the meeting preparation process (e.g., venue set up etc.)
- Support the incident reporting and investigation onshore.
- Coordinate the inspection and refilling of fire protection equipment for on/offshore (e.g., extinguishers, CO2bottles, Argo-55 etc.).
- Plan and deliver HSSE Projects (e.g., Safety Sign Improvement etc.) with Contractors
- Provide support to offshore HSSE team by coordinating all their requests with onshore stakeholders.
